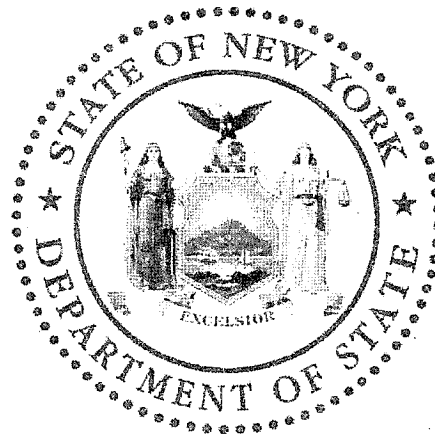

CERTIFICATE OF INCORPORATION

OF

THE ACT OF GOODWILL INC

Under Section 402 of the Not-for-Profit Corporation Law

FIRST: The name of the corporation is: **THE ACT OF GOODWILL INC**

SECOND: The corporation is a corporation as defined in subparagraph (a)(5) of Section 102 (Definitions) of the Not-for-Profit Corporation Law.

THIRD: The purpose or purposes for which the corporation is formed are as follows:

To purpose is to voluntarily assist any members in terms of difficulties to the extent to which the existing condition permits. We do this by financially helping the members of the community.

Feed The Hungry - Start "Feed the Hungry" Food Drive designed to address Human Poverty and Help Place an End to Human Hunger.

To Establish Community Relationship with Non-Muslims and Muslims. We do this by creating events and projects which will focus on Inter-Faith Understanding.

ISLAM (Islamic Scholars & Leaders for American Muslims) - will be an umbrella organization representing American Muslim through the United States of America. It will consist of Scholars (Imaam) and Professional Muslims (Leaders) to represent the American Muslim Community.

To receive any grant, donation, gifts, bequest or devise of real or personal property and to have the power to solicit and receive funding by any and all proper and appropriate means, to receive and disburse such funds or money accruing from tithes, offerings, collections or any other contribution for the general support of said Corporation under the State of New York.

To help individuals and families in Queens county and its surrounding areas to work to enhance the dignity and quality of life of individuals and families.

FOURTH: The corporation shall be a Type **B** corporation pursuant to Section 201 of the Not-for-Profit Corporation Law.

FIFTH: The office of the corporation is to be located in the New York County of State of **Queens**.

SEVENTH:

The Secretary of State is designated as agent of the corporation upon whom process against it may be served. The address which the Secretary of State shall mail a copy of any process accepted on behalf of the corporation is:

EIGHTH: Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code; or the corresponding section of any future federal tax code.

Notwithstanding any other provisions of these articles, the organization is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended and shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under IRC (501)(c)(3) or corresponding provisions of any subsequent Federal tax laws.

No part of the net earnings of the corporation shall inure to the benefit of any member, trustee, director, officer, of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

No part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation [except as otherwise provided by Internal Revenue Code section 501(h)], or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidates for public office.

NINTH: Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principle office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
